**Remarks:**

The enclosed Certificate is based upon the following conditions:

1. The Requirements stated in Class Programme DNV-CP-0484 and DNV-CP-0628 continue to be met. The Approval is conditional upon the firm maintaining the audited scheme and notifying DNV of any significant changes in personnel, equipment or procedures.
2. Company Supervisors and Authorized Personnel to carry out In-Water Surveys on Classification projects pertinent to this Approval is controlled by the Certificate Holder Training and Qualification Procedure.
3. RockSalt may carry out periodical in-water bottom surveys using remotely operated vehicles (ROV) "**Mohawk/Super Mohawk/Videoray**" (**Type ObsROV**) with DNV Surveyors present.
4. The survey with ROV or Diver shall provide the same results as for any ordinary survey performed in dry-dock. The survey shall be conducted under DNV supervision and attending surveyor may request additional inspection depending on the outcome of the survey.
5. For bottom surveys afloat (ships), requirements in DNV Rules for Ships, Pt.7 Ch.1 Sec.5 1.5 shall be observed. For Bottom surveys afloat (offshore units), requirements in Rules for classification: Offshore units — DNV-RU-OU-0300, Sec. 6, Sec. 1.3. For more details on how to perform bottom survey afloat, see DNV-OTG-08 Guidance on Bottom Survey. Company is to request to set up a kick-off meeting with DNV Attending Offshore Surveyor 2-weeks before diving to address:
  - a. Diving plan review,
  - b. Records of divers and Supervisors in the project,
  - c. Diving and equipment limitations,
  - d. Flag Authority diving plan approval, when applicable.
